FENCING COVENANT

In the Matter of the Fencing Act 1978

BETWEEN

Donald Edward PHILLIPS and Darren Kent BERKETT

("the First Owner")

AND

Donald Edward PHILLIPS and Darren Kent BERKETT

("the Second Owner")

BACKGROUND:

- A. The First Owner is the registered proprietor of the land described in the First Schedule (the "First Land").
- **B.** The Second Owner is the current registered proprietor of the land described in the Second Schedule (the "Second Land") which is occupied by Eden Endeavours Limited ("EEL").
- **C.** The First Owner and the Second Owner have agreed that the Second Land shall have the benefit of a fencing covenant under the Fencing Act 1978 in favour of EEL.
- **D.** The fencing covenant to be registered in relation to part Lot 200 DP 548842 relates to the eastern boundary of that Lot that adjoins Lots 5 and 37 DP 548842 only.
- **E.** The Second Land will be transferred to EEL following registration of this Deed apart from Lot 200 DP 548842 which will be further developed by the First Owner before part is transferred to EEL.

TERMS OF THIS DEED:

- 1. The First Owner, as proprietor of the First Land, shall be bound by a fencing covenant within the meaning of section 2 of the Fencing Act 1978 ("the Act") in favour of the Second Land, which is occupied by EEL.
- 2. For the avoidance of doubt, the First Owner acknowledges that:
 - EEL shall not be required to contribute to the cost of erection or maintenance of any boundary fences between the First Land and the Second Land;
 - b. the provisions of section 6(1) do not apply to this Deed and upon registration the provisions of this Deed shall run with the First Land and bind the First Owner's heirs, successors or assigns pursuant to section 5 of the Act.
